CONSULTATIVE MEETINGS ON SCHOOL AND COLLEGE CURRICULA AND ASSESSMENT REVIEW IN MALAWI

The Ministry of Education (MoE), through the Malawi Institute of Education (MIE), has embarked on reviewing school and college curricula and assessment procedures. The review focuses on pre-primary, primary, secondary and primary teacher education curricula. The purpose of the review is to align the school and the teacher education curricula with the aspirations of Malawians as stipulated in the Malawi 2063 Agenda. The school and college curricula review would critically support human capital development for socio-economic growth by empowering citizens with the critical knowledge, skills, values and attitudes required to navigate the rapidly evolving global world.

One of the review process activities is consulting all MDAs, DPs, CSOs and professional bodies in the education sector on the school and college curricula.  - a. Teacher preparation
 - b. Involvement of stakeholders
 - c. Resourcing the curricula
 - d. Leadership and management
 - e. Policies guiding curricula
